INTRODUCTION





Please be prepared to identify your actuator by the model number found on the label or in stamp marks on the side of the gear housing. i.e., A12-05B5-04D

REPAIR KIT INSTALLATION

NOTE: All screws can be replaced with standard machine screws (#12-24 and #10-32). Tighten all screws/nuts to 70 in-lbs. upon reassembly (except single screw in rear housing —tighten to 20 in-lbs.).

COVER TUBE




Remove 4 screws from front housing. Slip holder plate off of cover tube. Press cover tube off of extension tube. Replace in reverse order.

REAR HOUSING




Remove 4 screws from front housing and 1 screw from rear housing. Pull housing free.

Install one of the furnished plastic bumpers inside the new housing. The thick bumper is used for the DXX-05 actuator (5:1 ratio), the thin bumper is used for the DXX-10 and DXX-20 (10:1 & 20:1 ratio) actuators. Install the new housing in reverse order.

INTERMEDIATE GEAR SET




Remove rear housing as directed above. Slip washers and gear off of support pin.* To replace: If two different size washers are provided, the thick washer goes up against the front housing (goes in first).

CLUTCH KITS (BALL SCREW)




Remove rear housing and intermediate gear. Remove washer on top of clutch.

Slide clutch from screw shaft. Remove key. Remove washer underneath clutch. Two replacement washers and key are supplied with each kit.

Replace in reverse order.

DRIVE SCREW ASSEMBLY (BALL SCREW)



Remove cover tube, rear housing, intermediate gear and clutch. Slide brake and screw assembly out of front housing.


To reassemble, remove clamp from screw replacement kit. Slide screw with brake back through front housing being careful not to lose any brake components.

Reassemble in reverse order.

Two washers and key are supplied with each kit.


MOTOR



Remove rear housing as previously described. Remove 2 motor nuts from front housing. Pull motor free. (Take care not to disturb the gear train.) Replace in reverse order.

FRONT HOUSING (BALL SCREW)




Rear Housing

Remove cover tube and holder, rear housing, intermediate gear, clutch, drive screw and motor as previously described. Save all gaskets and seals or replace with new seals from seal kit below. Discard front housing. Replace with housing from replacement kit. Reassemble in reverse order.

It is advisable to replace the appropriate seals whenever the actuator is disassembled.
