1. General

1.1 About this manual

This manual contains mechanical and electrical installation instructions for the Thomson Electrak® XD electric linear actuator. It also contains, among other things:

- technical data
- installation data
- type designation key.

It is important to carefully read this manual before installing the actuator and to have the correct qualifications needed to perform the installation.

1.2 Target group

This manual addresses qualified mechanical and electrical personnel.

1.3 Symbols used



This symbol is shown to highlight a general warning, general instruction or as a warning for a mechanical hazard.

1.4 Transport and storage

The actuator may only be transported and stored in the original packaging supplied by Thomson. The temperature during transportation and storage must be between -40 to +85° C (-40 to +185° F). Avoid shocks to the package. If the package is damaged, check the actuator for visible damage and notify the carrier, and if appropriate Thomson as well.

1.5 Packaging

The packaging consists of a cardboard box. The box contains the actuator and this manual. For large quantity orders, bulk packaging may be used, in which case the packaging and the content will vary depending on the order agreement.

1.6 Disposal

Where required by law, used packaging and actuators are taken back by Thomson for professional disposal if the transportation cost is paid by the sender. Please contact Thomson for shipping information.

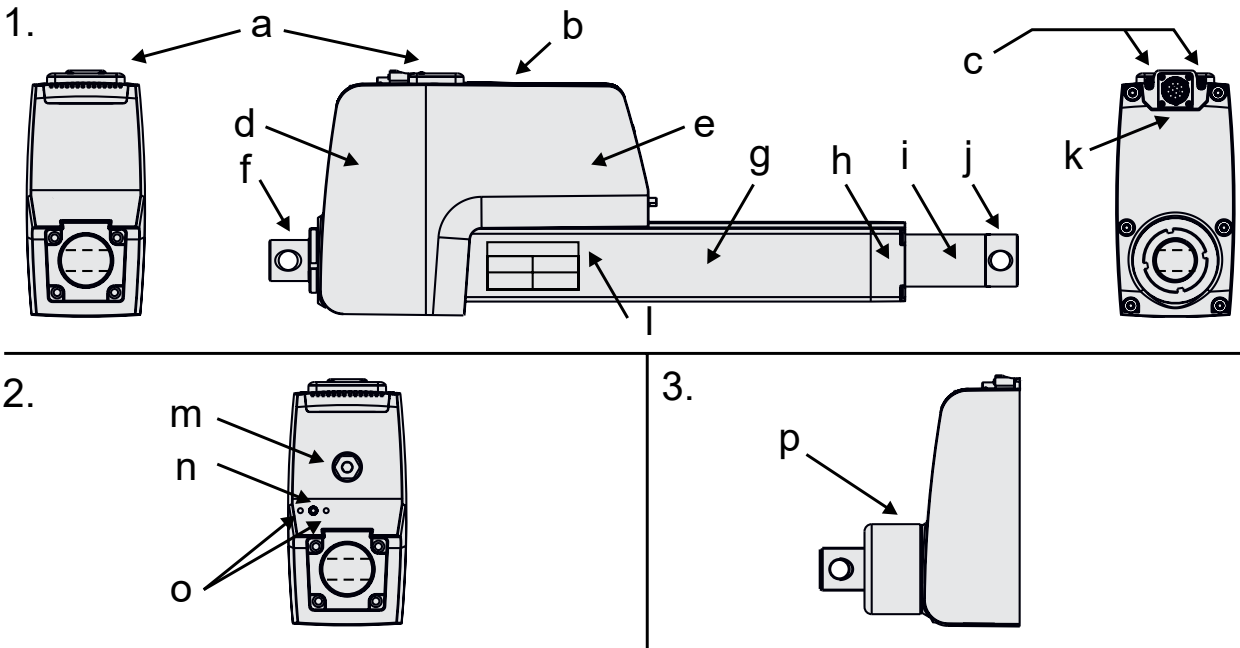
4. Installation

4.1 Product label

The product label can be found on the side of the cover tube. It will tell you which model of actuator you have, its basic performance data and where it is manufactured. Please study the product label to determine actuator type before starting any installation or service on the actuator. If you need any assistance from Thomson, please provide the serial number, manufacturing date and the designation of the actuator(s) in question. 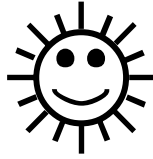

4.3 Operation environment



Min. -40° C (-40° F)

Max. +85° C (+185° F)

IP67 / IP69K

1. Operation temperature range is -40 to +85° Celsius (-40 to +185° Fahrenheit).
2. Protection degree against the ingress of water and particles is IP67 / IP69K.
3. Relative humidity range is 10 - 90 % non-condensing.



The protection class is valid only with a mating connector attached to the control signal connector in the actuator housing.

4.4 Mechanical installation

4.4.1 General installation safety notes



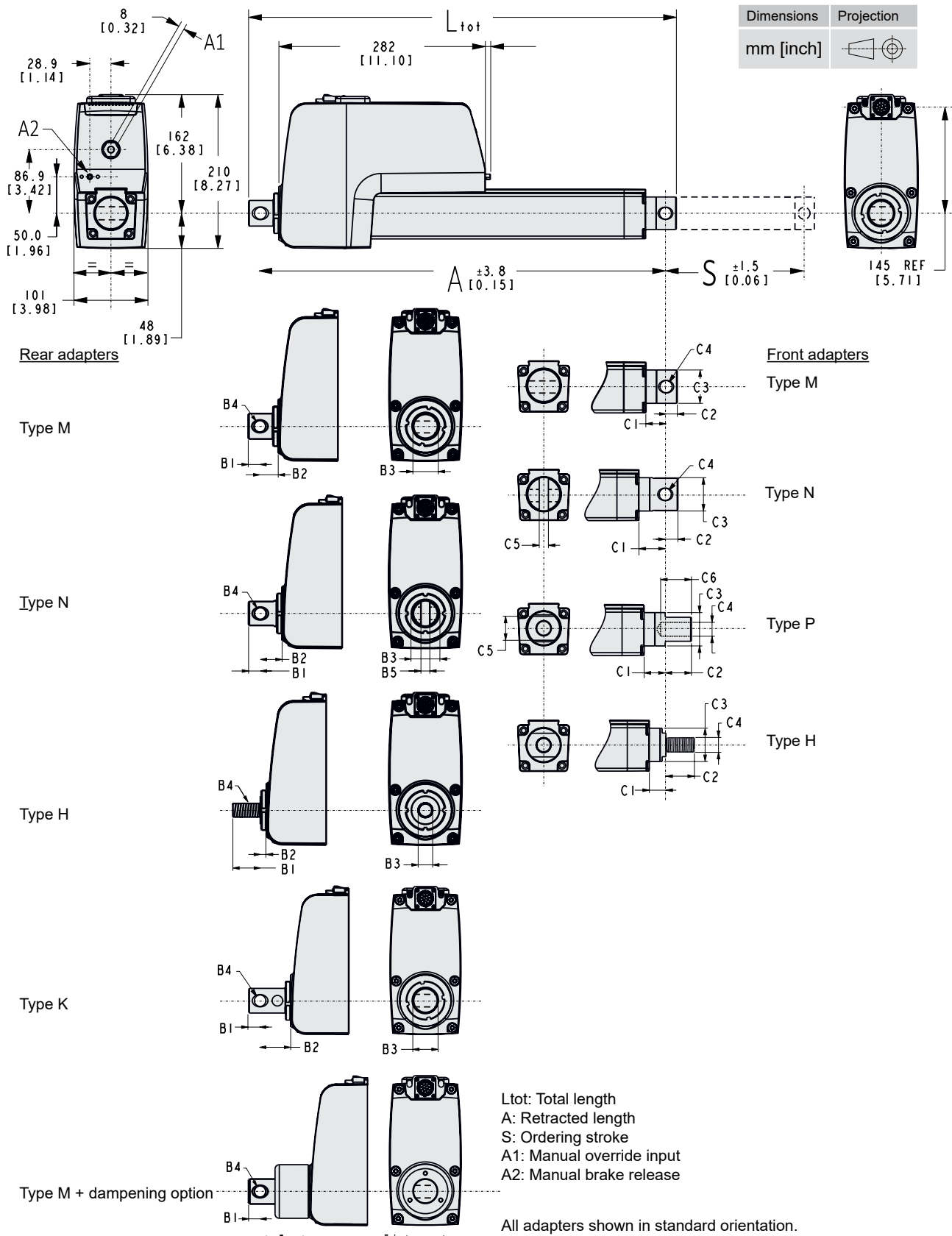
- Never work on the actuator with the power switched on.
- Do not hold the extension tube while the unit is energized.
- Failure modes of the actuator should be considered to ensure it does not create harm.

4.4.2 Basic installation considerations

1. Only mount the actuator using the holes in the rear and front adapters. Check the model number on the actuator product label (section 4.1) and then look at the ordering key (section 8.3) to find out your adapter type configuration. See the dimensions table and drawing (section 4.4.3) to find out the exact actuator and adapter dimensions.
2. Make sure that the actuator mounting position allows access to the power terminals cover plate and the control signal connector (section 4.4.5).
3. The power wires enter the rear housing through the power supply wire inlets while the control signals are connected by a cable to the actuator by using the control signal connector.
4. If the actuator is equipped with the optional manual brake release and override input, the lever and the input used to operate these must have enough free space around them to allow access (section 4.4.6).
5. Do not remove the grooved heat sink on top of the actuator.

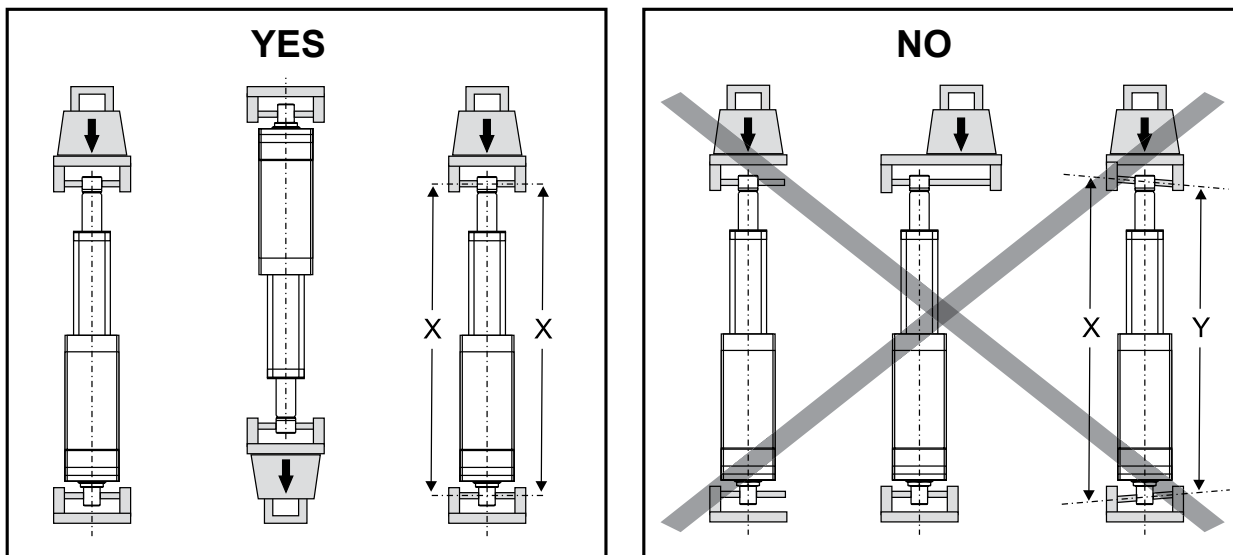

4.4.4 Mounting orientation and forces

1. The actuator can be mounted in any orientation and handle both pushing and pulling loads.
2. Always install actuator so that the force of the load acts in the center of the extension tube and the rear adapter.
3. Only mount the actuator to the rear and front adapter mounting holes.
4. Only use solid mounting pins and support them at both ends.
5. The mounting pins must be parallel to each other both radially and axially.



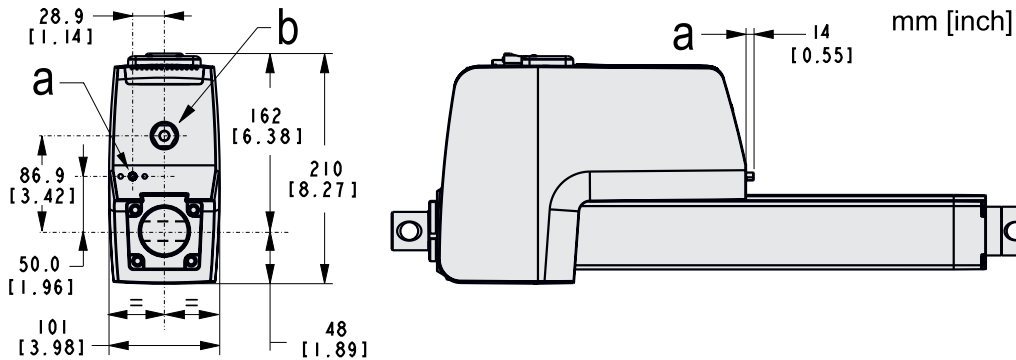
4.4.5 Electrical connections

The actuator is connected to the power supply by two wires to the power terminal studs situated under the power terminal cover plate (a), while the control signals are connected to the control signal connector (b) (section 4.5.3).



4.4.6 General manual brake release and manual override notes - optional features

Make sure when mounting the actuator that there is space enough between the front of the motor and any object to allow both the manual brake (a) release and the override (b) controls to be operated. See drawing below for their positions and dimensions.

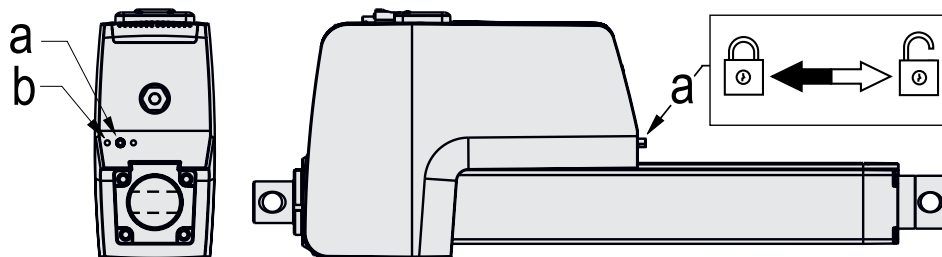


- Always make sure to switch off the power to the actuator before using the manual brake release or manual override.
- Never use the manual brake release and the manual override at the same time.
- Carefully read all operation instructions before using the manual brake release or manual override (section 4.4.7 and/or 4.4.8).

4.4.7 Manual brake release operation - optional feature

The manual brake release allows the holding brake to be manually disengaged from the extension tube so that it can be moved by gravitational force or by pushing or pulling it.

1. The manual release lever (a) can be pulled to open the holding brake and allow the extension tube to be disconnected from the holding brake.
2. If there is a helping load acting on the load/extension tube, it might start to move (backdrive) directly upon release in the direction of the helping load. Only the friction from internal components and the assembly will hinder the extension tube/load to backdrive.
3. The force to release the brake is 67 N (15 lbs), with a stroke of 10 mm (0.4 inch). Lower forces will open the brake partially and allow slower, more controlled movement. The lever has an inside threaded hole (10-32") that can be used to attach a cable/linkage for controlling it remotely.
4. The two M5 mounting holes (b) can be used to install a customer provided bracket in case a cable/linkage assembly is used for remote operation of the lever.



- In the case of a helping load, the operator must ensure releasing the actuator will not create a hazardous situation due to backdriving.
- The backdriving speed of the actuator may be higher than the rated speed of the actuator.
- To limit the maximum speed of the actuator with a helping load, the actuator must be coupled to a power source capable of current regeneration (i.e. batteries or a bidirectional power supply). In the case of an actuator release at full load, the regeneration current will vary depending on the battery size or the regeneration capacity of the power supply.
- Make sure to let the lever fully return to its innermost position before resuming operation.

4.4.8 Manual override operation - optional feature

The manual override allows the extension tube to be moved at power off by manually cranking it in the desired direction using the manual override input.

1. To operate the manual override, remove the cover plug (a) using a 8 mm hex bit. Then turn on the manual override input hexagon (b) using an 8 mm hex bit (c).
2. To extend the actuator, the override hub must be rotated clockwise (c).
3. The maximum torque required to move the extension tube at the fully rated actuator load using the manual override is typically 6 Nm (51 in-lbs).
4. The distance the extension tube travels per manual override input revolution depends on the actuator type. See the table below.

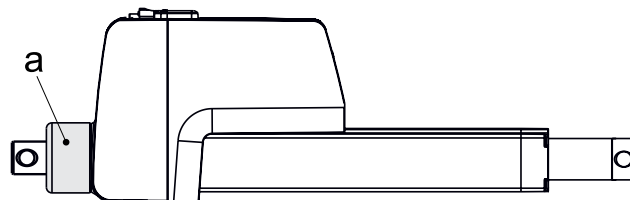

- Do not apply higher torque than 9 Nm (80 in-lbs) to the manual override input.
- In case that torque is exceeded, a mechanical fuse will break and render the manual override inoperable to protect the actuator. The fuse can only be replaced at the factory.
- Never run the extension tube into the end of stroke as that may damage the actuator.
- If a power tool is used to operate the manual override, its speed should not exceed 500 rpm, and it should start and stop smoothly.
- The override has a maximum run time of 1 minute and requires a 5 minute cool-down between events.

4.4.9 Shock load dampener - optional feature

The shock load dampener will absorb shock loads subjected to the actuator along the extension tube axis. When doing so the actuator adapters will move up to ± 3 mm (0.12 in) from their original position as the dampening elements in the dampener (a) compress or extends, which the mounting assembly must allow for.



- Do not attempt to open, no serviceable parts inside.

4.5 Electrical installation

4.5.1 General notes



- Make sure the leads/cables leading to the motor can handle the maximum motor current.
- An emergency stop is recommended to reduce the chance of a crushing hazard.
- Never work on the actuator or the wiring with the power switched on.

4.5.2 Fuse

Use a slow blow fuse on the supply voltage input wiring to protect the actuator and the wiring. Size it in accordance with local regulations and the current draw for the application in question.

4.5.3 Electrical connections

The actuator needs to be connected to a power supply and to the control system as described below.

Connection of power supply

The power leads are brought in to the actuator using the power wire inlets and are connected using the M6 sized ring terminal studs accessed by removing the power terminal cover plate. The power terminal cover plate is held in place by two screws (2 × M3 × 8, T10 Torx). The length of the ring clips may not be longer than 34.5 mm (Amax). Do not exceed 4 Nm (35 in-lbs) when torquing the lock nuts on the power studs. Never run the actuator with the cover plate removed.

Connection of control signals

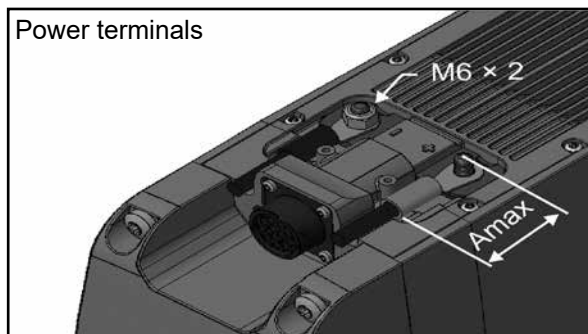
The control signals are connected to the signal connector using a mating connector and are secured to each other with a ring screw. Make sure to tighten the ring screw properly to ensure proper function and sealing. Exactly how to connect the control signals depends on which type of control your actuator is equipped with and how you choose to use it (section 4.6.12 to 4.6.17).

Mating connector data

Amphenol Ecomate connector with normal backshell: RTS6BS14N12P03, 12 pin

Amphenol Ecomate connector with short backshell: RTS6BS14N12PHEC03, 12 pin

Amphenol Ecomate pin terminal: SP24M2F which is for 24 - 26 AWG / 0.14 - 0.25 mm² leads (part number depends on the wire gauge / cross section of the leads being used).



4.5.4 Power supply lead cross section

To avoid malfunction due to voltage drop, the cross section of the leads between the actuator power terminals and the power source must be of sufficient size in order to prevent the supply voltage to drop to levels below the supply voltage limit of the actuator. Calculations to determine the necessary cross section should take local regulations, application specifics and the actuator supply voltage limits into account.

4.5.5 Power supply requirements

The power supply used to power the actuator must fulfill the following requirements.

1. The power supply must be sized so that it can handle both the average power over the duty cycle, as well as the peak current and the inrush current (section 4.5.6).
2. The power supply must be able to handle the energy that the motor regenerates.
3. At low temperatures down to -40 °C (- 40 °F), the power required can be up to two times higher than normal.



When the motor decelerates, brakes or is being rotated when using the manual brake release, it will work as a generator and send energy back to the battery/power supply. Under a helping load condition this energy can correspond to up to 60% of the nominal power rating for the actuator in question. The battery/power supply and the rest of the system must be able to handle this regenerated energy.

4.5.6 Inrush current

At the start of the actuator motion, there is an inrush current that can be up to $3 \times$ the rated current that can last for up to 500 ms.



If using an AC-powered power supply, it must be sized to handle the inrush current (batteries typically have no problem delivering the inrush current). Also contacts, switches and relays must be sized appropriately to be able to handle the inrush current.

4.6 Control options installation and operation

4.6.1 General notes



- Avoid placing signal cables along power cables to reduce the risk of interference.
- Avoid using a vehicle earth as the return conductor. Instead use a two wire system to reduce the risk of interference.
- In very sensitive applications or where there is a risk of interference we recommend using shielded signal cables.
- Keep in mind that long cables in combination with small lead cross sections and low voltages may lead to undervoltage and malfunction due to voltage drop.
- Relays or other coil operated devices should have spark protection to avoid interference.
- Never work on the actuator or the wiring with the power switched on!

4.6.2 Speed control by adjusting the input voltage



Electrak XD cannot be speed controlled by adjusting the input voltage. When using battery or full wave rectified direct currents that are within the acceptable voltage limits, the built-in Electronic Monitoring Package will keep the actuator at the correct speed. Outside of the limits, the actuator will be stopped (also see section 4.6.3). When attempting to use Pulse Width Modulation (PWM) to speed control the actuator, the internal PCB will be permanently damaged and cause malfunction.

4.6.3 Electrak Monitoring Package

All controls are equipped with the Electrak Monitoring Package which includes the following features and functions.

4.6.5 Extend and retract inputs

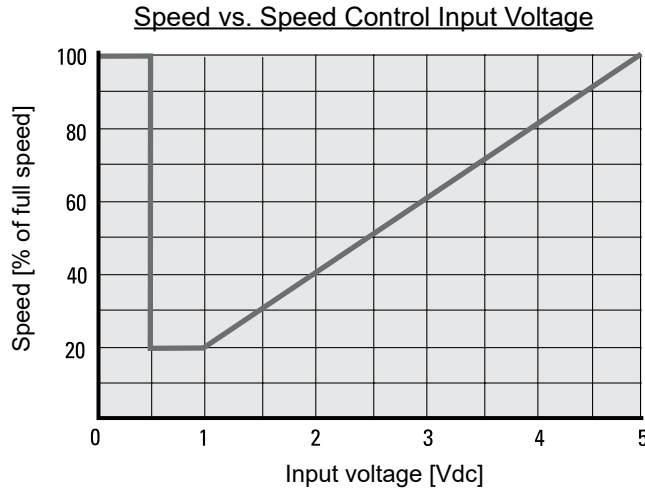
The extend and retract inputs let you control the direction of the extension tube motion using low-level voltage signals to switch the motor. If both signals are inactive or active at the same time, the actuator will remain still or stop. For wiring, see the wiring diagram for your control option (also see section 4.6.3).

4.6.6 Speed control input (not applicable for units with option CNO/COO)

If the speed control input is not used when the extend and retract inputs are active, the actuator will move at its full speed as long as the max. load is not exceeded. If a 0 - 5 Vdc signal is connected to the speed control input, the speed of the actuator can be regulated between 20 - 100% of its full speed where 0 - 0.5 V corresponds to full speed and 1 - 5 V corresponds to 20% of full speed up to full speed. For wiring, see the wiring diagram for your control option (also see section 4.6.3).

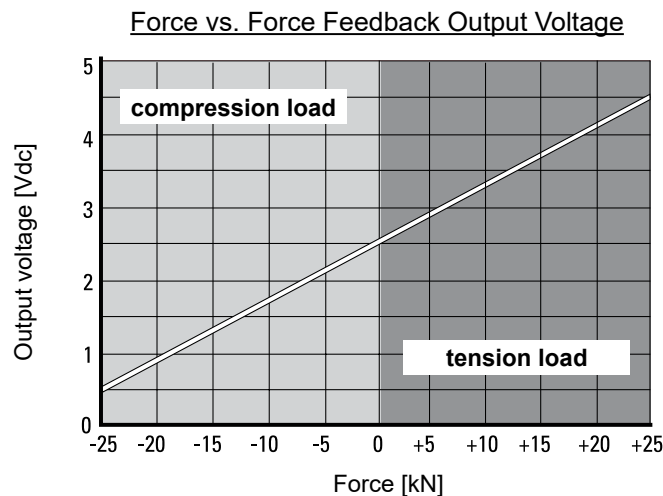

4.6.7 Force feedback function (not applicable for units with option CNO/COO)

In order to use the force feedback output, the actuator must be equipped with an integral force feedback sensor (rear adapter type K). The force output is a 0 - 5 Vdc signal where 2.5 V is zero force, 0.5 V is 25 kN compression force and 4.5 V is 25 kN tension force. Between 0.5 - 4.5 V, the output changes 1 mV per 12.5 N in change of force. For wiring, see the wiring diagram for your control option (also see section 4.6.3).

4.6.8 Force feedback function for options CNO/COO

In order to use the force feedback function, the actuator must be equipped with an integral force feedback sensor (rear adapter type K). The force is then sent over the bus according to the message structure for the type of bus being used. For SAE J1939 CAN bus (option CNO), see section 5 and for CANopen® (option COO), see section 6. For wiring, see the wiring diagram in section 4.6.17.

5.2.2 Address

The Electrak XD uses a default address value of 35 (0x23). In applications where the default address is not available, there are three additional methods in choosing a new address.

1. The Electrak XD device is arbitrary address capable. If another device with a higher priority NAME contends for the selected address, the actuator will continue to request other addresses until it finds one that it can claim.
2. The Electrak XD device can also use the commanded address PGN to select a specified address. See SAE J1939/81 for more details about address claiming.
3. In some applications, it may be more convenient to select an address through hardware switches. Activate the desired address select input by connecting it to positive and address select common to negative. This allows the user to change the default address using the address select inputs as defined in the table below. Activating individual select pins will create a binary adder to the default address. This method can allow up to 8 individual actuator addresses on a single bus. The below chart shows some examples on how this can be implemented. Note that conflicting messages produce arbitrary execution.

5.2.3.3 Target speed

Controls the target speed of the actuator. Can be set between 20 % of and up to the nominal speed of the actuator model. See table in section 8.1 for the speed of each actuator model. Any speed set outside the limits will result in a parameter error being sent. Example: if the speed in table 8.1 is 65 mm/s for the actuator in question, the target speed can be set between $0,2 \times 65$ to 65 mm/s (13 - 65 mm/s).

5.2.4.6 Error flags

Bit 1 – Current/load overload: This flag is used to inform the user that the last motion the actuator attempted caused an overload condition. This occurs when the actuator determines the current set in the Current Limit object from the ACM is exceeded for a consecutive 15 ms. This flag is also set if the set Load Limit is exceeded (section 5.2.3.4). When this flag is set by the actuator the user must reset the Motion Enable bit in the ACM before attempting additional motion from the actuator.

Bit 2 – Voltage error: This flag is used to inform the user that the operational voltage is outside of allowable running parameters. Any motion already in progress will continue for 10 seconds, but additional movement request will not be allowed until the operational voltage returns within the normal operating range.

Bit 3- Temperature error: This flag is used to inform the user that the operational temperature is outside of allowable running parameters. Any motion already in progress will continue for 10 seconds, but additional movement request will not be allowed until the operational temperature returns within the normal operating range.

Bit 4 – Backdrive detected: This flag is used to inform the user that the actuator has determined positional movement in the extension tube that was not commanded from the user. This can be caused from excessive static load or vibration being applied to the actuator.

Bit 5 – Message timeout: this flag is used to inform the user that no control message has been received within the time specified in the timeout time settings parameter. The default value is 5000 ms.

Bit 6 – Fatal error: This flag is used to inform the user that the actuator was unable to detect any motion while trying to run the motor. When this flag is set by the actuator the user must reset the Motion Enable bit in the RPDO before attempting additional motion from the actuator. Repeated activation of this flag indicates problems with the actuator, and it is recommended to contact the factory for additional support.

Bit 7(MSB) - Memory error: This flag is used to inform the user that the internal memory of the actuator is corrupted.

6.1 Introduction to CANopen

6.1.1 CANopen standard

This document assumes the reader is familiar with the CiA 301 specification released by CAN in Automation. Terminology from the standard is used, but not described in detail. The Electrak® XD actuator is compliant with the standard. The default baud rate is 500 kbit/s, and it will only support the standard CAN frame with 11-bit identifier field.

6.1.4 NMT State

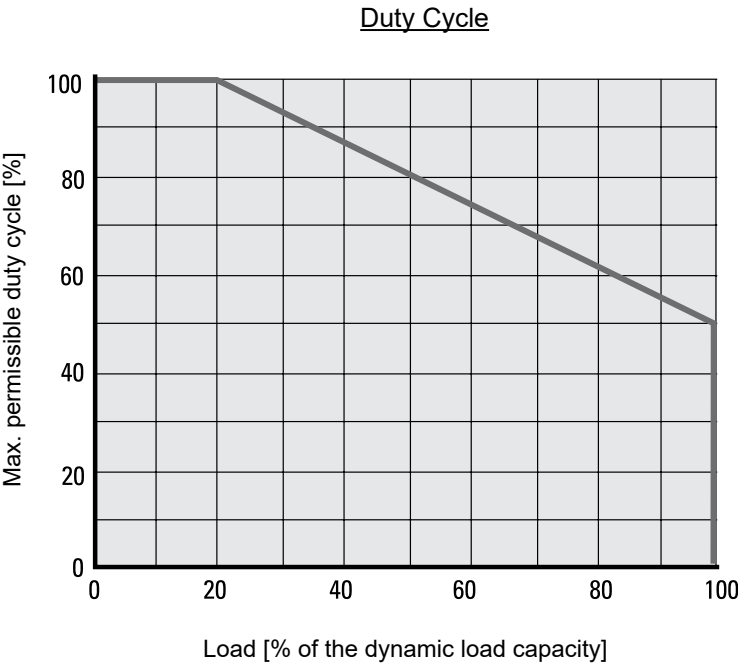
